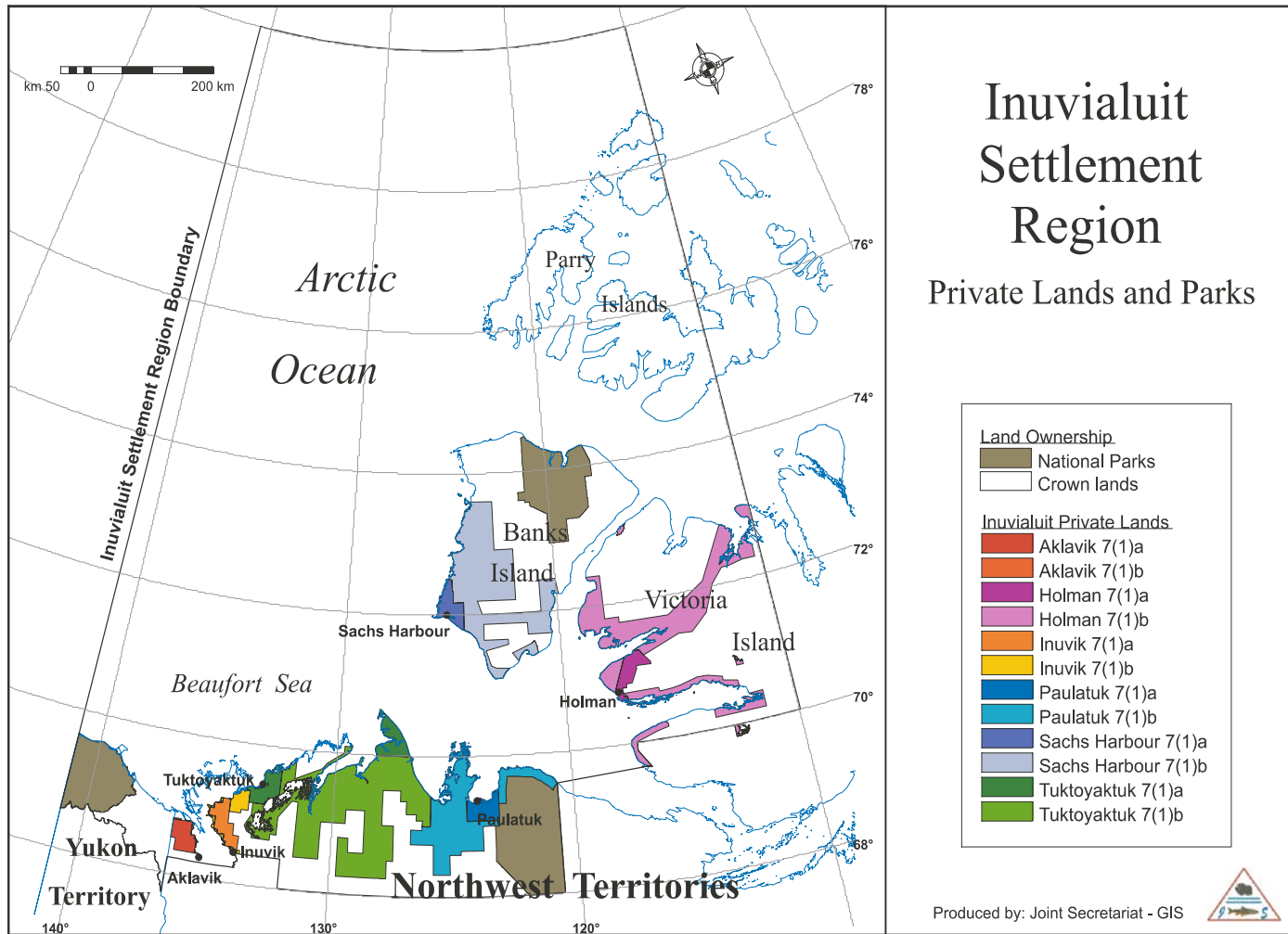


Figure 1. Private Inuvialuit Lands and Crown Lands within the Inuvialuit Settlement Region.

CHAIR'S COMMENTS

The Environmental Impact Review Board (the EIRB) held three regular meetings and five teleconferences during the year.

In 2002, the Environmental Impact Screening Committee (EISC) referred two projects to the Environmental Impact Review Board for public review.

Commander Resources' Proposed Diamond Exploration Program, Victoria Island, NWT was referred on September 6, 2002. The developer submitted its Environmental Impact Statement (EIS) to the EIRB in late November. Public meetings were then held in Holman, NWT on February 5 and 6, 2003 to hear the views of the community regarding this project. The EIRB Review Panel considered all of the information before it and their decision, contained in a final report, was released on February 18, 2003. The Review Panel recommended that the project proceed subject to certain terms and conditions, which included mitigative and remedial measures.

The second development WesternGeco Mackenzie Delta River 2D Seismic Program 2002 was referred on June 18, 2002. The developer postponed submission of an EIS to carry out research on their project during the summer of 2002. The developer then submitted its EIS, which included their research results, on January 7, 2003. Public meetings are scheduled to be held in Aklavik, Tuktoyaktuk, and Inuvik in mid April, 2003.

Again this year the EIRB worked on developing criteria for establishing acceptable environmental standards and evaluating a developers standard of performance for the Husky Lakes Area as required by Section 8 (1) of the *Inuvialuit Final Agreement*. The Board held a workshop in May in Inuvik which was attended by twenty interested parties. A draft of the criteria was circulated in June. Members of the EIRB travelled to Inuvik and Tuktoyaktuk in August to meet with the Inuvik and Tuktoyaktuk Hunters and Trappers Committees to discuss the draft.

Discussions continued throughout the year on ways to avoid duplication of processes should a pipeline be built through the Inuvialuit Settlement Region (ISR) and the Mackenzie Valley. In June, 2002 a final version of the Cooperation Plan was released for public comment.

As Chair of the EIRB, I wish to thank my fellow board members, our secretary, Jonathan Allen, our advisors and all the staff of the Joint Secretariat for their efforts to help the EIRB provide a fair and efficient review procedure for the Inuvialuit Settlement Region.

PERIOD OF REPORT

This report describes the affairs of the EIRB for the fiscal period of April 1, 2002 to March 31, 2003. During its sixteen years of operation the EIRB has produced fifteen Annual Activity Reports.

AUTHORITY OF THE ENVIRONMENTAL IMPACT REVIEW BOARD

The EIRB was established under the terms of the Inuvialuit Final Agreement (IFA) between Canada and the Committee for Original Peoples Entitlement (COPE), representing the Inuvialuit. The IFA was approved, given effect, and declared valid by the *Western Arctic (Inuvialuit) Claims Settlement Act* [sec. 32 - 33 Elizabeth II, C.24.] on June 28, 1984.

The IFA provides the groundwork for a two-stage Environmental Screening and Review Process that is carried out by the EISC and the EIRB [IFA Section 11.0]. The EISC conducts environmental screening of development activities proposed for the Inuvialuit Settlement Region. The EIRB carries out detailed environmental impact assessment and public review of development projects referred to it by the EISC pursuant to the IFA.

The EIRB is structured so that both parties to the IFA, the Inuvialuit, and the Government of Canada are represented equally. The goals of the IFA, directly relevant to EIRB operations, are:

- *to preserve Inuvialuit cultural identity and values within a changing northern society;*
- *to enable Inuvialuit to be equal and meaningful participants in the northern and national economy and society, and*
- *to protect and preserve the Arctic wildlife, environment, and biological productivity.*

MEMBERSHIP

The EIRB is composed of seven people. Three members are appointed through Order-in-Council by the Government of Canada; three members are appointed by the Inuvialuit Game Council (IGC); and a Chair is selected by the Government of Canada with the consent of the IGC. Of the three members appointed by Canada, one is nominated by the Government of Yukon, one is nominated by the Government of the Northwest Territories, and one is selected by the Government of Canada.

REVIEWS

During the year, the EISC referred two proposed projects to the EIRB for review. These projects were:

- Commander Resources' Proposed Diamond Exploration Program, Victoria Island, NWT
- WesternGeco's Mackenzie Delta River 2D Seismic Program 2002

The EIRB RP served as the Secretary to the EIRB and its subsequent Review Panels for each review. Barbara Berg and Myrna Button assisted the RP and both Review Panels in the completion of the reviews.

On September 6, 2002, the EISC decided to refer the Commander Resources' proposal to the EIRB for review. The EIRB had 26 Registered Participants for the Commander Review. The Technical Advisor was Peter Krizan, a Wildlife Biologist; and Legal Counsel was Debra Fendrick of Austring, Fendrick, Fairman and Parkkari. The Chair for this Panel was Robert Hornal and the Panel members were Jack Akhiatak, Peter Bannon, Richard Binder, and Tom Butters. Meetings were held in the community of Holman, NWT, on February 5 and 6, 2003. The "Commander Review" report was released publically on February 17, 2003. The final report, containing the recommendations of the Review Panel, was forwarded on February 18, 2003, to the Minister of Indian Affairs and Northern Development. The Minister approved the proposal, taking into consideration most of the EIRB Review Panel's recommendation.

On June 18, 2002, the WesternGeco proposal was referred to the EIRB from the EISC, for review. WesternGeco then put the review process on hold from June 26, 2002, until November 25, 2002. There were 30 Registered Participants for this review. The EIRB retained Bill Griffiths, an Aquatic Biologist with LGL Environmental Consultants in Sidney, British Columbia, as the Technical Advisor; and Debra Fendrick of Austring, Fendrick, Fairman and Parkkari in Whitehorse, Yukon, as the Legal Counsel. The Chair for this Panel was Robert Hornal and the Panel members were Herbert Felix, Peter Bannon, Richard Binder, and Tom Butters. Public meetings were scheduled for Aklavik, Tuktoyaktuk, and Inuvik on the 14th, 15th, and 16th of April 2003, respectively. The final report, containing the recommendations of the Review Panel, was forwarded on May 6, 2003, to the Minister of Indian Affairs and Northern Development. The Minister approved the proposal, taking into consideration most of the EIRB Review Panel's recommendation.
