


Figure 1. Private Inuvialuit Lands and Crown Lands within the Inuvialuit Settlement Region.

CHAIR'S COMMENT

The Environmental Impact Review Board (EIRB) secured appointments necessary to resume normal operations during the review period. The EIRB held two regular meetings and two teleconferences during the year. The EIRB agreed upon a schedule and work plan to guide normal operations for the upcoming year. In addition, it commenced the process for a review of a project that was later withdrawn by the proponent prior to the formal review.

Following the Chair's appointment on February 1, 2005, other outstanding appointments were secured for a three year period. Mr. David Loeks was appointed as the Yukon government appointee on March 31, 2005 and Mr. Tom Butters was reappointed on April 6, 2005 as the Government of Canada appointee. In September 2005, the Inuvialuit Game Council confirmed the reappointments of Mr. Jack Akhiatiak and Mr. Herbert Felix. Mr. Eric Cockney was appointed to replace Mr. Richard Binder who resigned to assume a position at the Community Support Unit of the Joint Secretariat. Mr. Larry Peckford was appointed as the EIRB Environmental Review Coordinator and resource person. With these appointments the EIRB will have the benefit of stable membership and assistance for the near future. The appointment of the GNWT nominee remains outstanding.

The Environmental Impact Screening Committee (EISC) referred the **Proposed JOGMEC/NRCan Mackenzie Delta Program for Drilling of Mallik 6L and 38 and Potential Re-entry Well: Gas Hydrate Research Project 2006-2008** to the Board on March 17, 2006. On April 3, 2006, the developer informed the EIRB that they were withdrawing their proposal and did not wish to proceed with the review.

The EIRB continued to work on developing criteria for establishing acceptable environmental standards and evaluating a developer's standard of performance for the Husky Lakes Area as required by Section 8(1) of the Inuvialuit Final Agreement. A draft document was adopted by the EIRB for final consultation during the calendar year with affected communities, the Inuvialuit Land Administration, government and interested parties.

The EIRB and EISC held a joint meeting to explore areas of common interest and agreed upon areas where they could continue to work together. The Chairs of EIRB and EISC also signed a Memorandum of Cooperation with the Mackenzie Valley Environmental Impact Review Board to share information and experience especially in areas of transboundary activities.

The EIRB, through the Chair, participated on the newly formed Board Forum comprised of the Chairs of NWT non-renewable resource regulatory, advisory and environmental assessment boards, the federal government and the GNWT. As the Chair of the EIRB, I wish to thank fellow Board members, Larry Peckford, Peggy Madore and the staff of the Joint Secretariat for their efforts to help the Board provide a fair and efficient review procedure for the Inuvialuit Settlement Region. I would also like to thank Richard Binder for his services as a member of the EIRB since 1998 and wish him well in his new endeavours.

PERIOD OF REPORT

This report describes the affairs of the Environmental Impact Review Board (EIRB) for the fiscal period of April 1, 2005 to March 31, 2006. During its nineteen years of operation the EIRB has produced eighteen Annual Activity Reports.

AUTHORITY OF THE ENVIRONMENTAL IMPACT REVIEW BOARD

The EIRB was established under the terms of the Inuvialuit Final Agreement (IFA) between Canada and the Committee for Original Peoples Entitlement, representing the Inuvialuit. The IFA was approved, given effect, and declared valid by the *Western Arctic (Inuvialuit) Claims Settlement Act* [S.C. 32 - 33 Elizabeth II, C.24.], on June 28,1984. The IFA provides the groundwork for a two-stage Environmental Screening and Review Process that is carried out by the Environmental Impact Screening Committee (EISC) and the EIRB [IFA Section 11.0]. The EISC conducts environmental screenings of development activities proposed for the Inuvialuit Settlement Region. The EIRB carries out detailed environmental impact assessments and public reviews of development projects referred to it by the EISC pursuant to the IFA.

The EIRB is structured so that both parties to the IFA, the Inuvialuit, and the Government of Canada are represented equally. The goals of the IFA, directly relevant to EIRB operations, are:

- to preserve Inuvialuit cultural identity and values within a changing northern society;
- to enable Inuvialuit to be equal and meaningful participants in the northern and national economy and society; and
- to protect and preserve the Arctic wildlife, environment, and biological productivity.

MEMBERSHIP

The EIRB is composed of seven people. Three members are appointed through Ordersin-Council by the Government of Canada; three members are appointed by the Inuvialuit Game Council (IGC); and a Chair is selected by the Government of Canada with the consent of the IGC. Of the three members appointed by Canada, one is nominated by the Government of Yukon, one is nominated by the Government of the Northwest Territories, and one is selected by the Government of Canada.
