About this document:

Developers must complete this online questionnaire to officially register the project on the Public Registry, and inform the EISC about the activities associated with the proposed project. In the questionnaire, a Developer may request:

- That the proposed project proceed directly to Phase 2 of the environmental impact screening process as it is a development as defined by the IFA and not exempt from screening; or
- That the proposed project be reviewed to determine whether it is subject to the environmental impact screening process, and/or whether it is exempt
 from screening.

A direct referral to Phase 2 must include a Project Description per the EISC Guidelines which is to be submitted to the EIS Co-ordinator for the determination of its completeness for the purposes of screening. Once deemed complete it will be uploaded to the Public Registry and a Notice of Proceed will be issued

A request for a pre-screening to determine whether or not a screening is required, triggers the Screening Committee to use the information provided in this on-line questionnaire, to decide:

- · whether the proposed project is a development as defined by the IFA, and
- if the proposed project is a development, then whether the proposed project is exempt from environmental impact screening proceed; or
- if the proposed project is not a development, then inform the Developer, post the decision on the Registry and close the file.

Notwithstanding the inclusion of a type of development on the Exclusion List, Inuvialuit exercising their rights under s.11(1)(c) of the Inuvialuit Final Agreement may request an environmental screening of an exempt development. In extraordinary circumstances the Screening Committee may also decide, on its own motion that a development on the Exclusion List will be subject to an environment screening. In any such case, the Screening Committee will provide reasons for its decision.
