## RE: Inuvik to Tuktoyaktuk Highway Project

The purpose of this letter is to seek the Inuvialuit Regional Corporation's input regarding the Inuvik to Tuktoyaktuk Highway Project (the "Project"). The Project is a proposed all-season highway linking the communities of Inuvik and Tuktoyaktuk. If it proceeds, the Project will be located entirely within the Inuvialuit Settlement Region (ISR), including on lands owned by the Inuvialuit. The Project is currently undergoing a review by the Environmental Impact Review Board (EIRB), a public review process that was established by the Inuvialuit Final Agreement (IFA). The Project is also subject to a federal review under the Canadian Environmental Assessment Act which has been substituted by EIRB's review process. If the project is approved following this review it will require various permits, licenses, or other authorizations from federal regulatory departments.

If you are concerned that the Project could adversely affect Inuvialuit interests, the Government of Canada encourages you to make your concerns known through the EIRB's public review process as this body is responsible for recommending whether the Project should proceed and, if so, under what terms and conditions. The EIRB process is designed to respect the principles of the *Inuvialuit Final Agreement* and it provides the opportunity to understand the nature of the Project and its impact on the environment as well as the opportunity for parties to provide their own views and perspectives on the issues. Federal departments and agencies are participating in the public review process and will be aware of any concerns you make to the EIRB. The Government of Canada intends to rely on the EIRB review to fulfill its consultation obligations, if any.

There are public sessions for the Project, organized by EIRB, scheduled over the coming months. Technical sessions are currently scheduled for August 22-23 in Inuvik while the public hearings are currently scheduled to take place September 20-21 in Tuktoyaktuk and September 24-25 in Inuvik. These sessions provide an opportunity for parties to express their opinions on the Project and they are the primary mechanism through which the Government of Canada will gather information, concerns, and potential impacts



related to the Project. We encourage your participation at those events. If you have any questions about the EIRB process or public sessions, we recommend you contact the Board directly.

The Northern Projects Management Office (NPMO) is responsible for coordinating the Government of Canada's participation in the EIRB review. Kate Witherly is NPMO's project officer for the Project.
