- 6. CREDIT: Contractor's screen credit shall appear as Production Assistant, Camera Operator, Location Scout, and any others deemed appropriate.
- 7. OWNERSHIP: Producer shall be the owner of all of the results and proceeds of the Contractor's services, including any copyright, trademark, and any other intellectual property rights in any work or property created by the Contractor, or anyone under the Contractor's direction.
 - Contractor acknowledges that Contractor's work is a "work made for hire" and therefore the Producer shall be the author and copyright owner of any work created under this agreement. In the event that any of the proceeds of the Contractor's work are not considered a work for hire, then the Contractor's copyright to such work is hereby assigned to the Producer.
- 8. CONFIDENTIALITY: Contractor shall not directly or indirectly circulate, publish or otherwise disseminate any news story, article, book, or other publicity concerning the Film without Producer's prior consent,

provided that Contractor may issue personal publicity mentioning the Film so long as such references are not derogatory.
